It was purposed that instead of having representative voting by the state presidents that each member would vote electronically. This would be both expensive to set up, \$10,000 or more, and no assurance of participation. Another big issue was insuring that states and chapters don't infringe on intellectual property. It is mandatory that chapter, state, and international printed materials, written work, images, cartoons, artwork, only print materials that have written permission of the author and/or artist. Printing the author's name is not enough. Many lawsuits have been brought forth .Each chapter and state needs to sign the Hold Harmless Agreement. Delaware chapters should forward the signed Hold Harmless Agreement to the State President Marjorie Chappel. When in doubt don't use it. Go to sites of free materials or create your own.

State Parliamentarian Barbara Vann, second vice president Doris Persons, and state president Marjorie Chappel represented Delaware, Alpha Tau State, at the Indianapolis 2014 International Convention. We learned a lot in workshops. It is very important for teachers and women to become involved in local and state politics. Laws are being passed that affect our lives. Human trafficking is a big issue in the United States. Tougher laws need to be passed to protect women and children. Our Delaware group also had fun shopping, dining, and meeting our Delta Kappa Gamma sisters from all over the world.



#### National Legislative Seminar for Key Women Educators, March 16 - 19, 2014

We nod our heads. Perhaps we make a soft affirmative sound, "Yes." We are advocates-- at least personally. Yet, are we active advocates? Do we do, say, or write something about a legislative or social idea, action, or law which we condone or condemn? How do we feel about the future of education (Common Core, STEM, testing, etc.)? How do we feel about human trafficking or sexual harassment or pay equity? These topics were addressed at the DKG US Forum's National Legislative Seminar for Key Women Educators. Held in Arlington, Virginia, March 16 – 19, this year's theme was "Women Poised for Legislative Action."

Two DKG members presented interesting research on STEM (science, technology, engineering and math). Their conclusion included the emphasis on the importance of students mastering basic skills in reading, math, critical thinking, and ethics. Also, money is being diverted from NASA and given to the Department

of Education; however, while STEM is a major proponent of NASA's educational programs, currently there is no individual in charge of STEM at DOE. What can we do? First, we can educate ourselves about STEM. We can encourage the development of good STEM programs, which include ethics. Another thing that we can do is contact our legislators and, perhaps, the Congressional Committee on **Education and Work** Force.

## More from Legislative Seminar

Another session focused on human trafficking, particularly the exploitation and sexual abuse of children, both boys and girls. This is a growing problem. One organization that works with vulnerable children is FAIR. This group hopes not only to identify children who are "trafficked" but also hopes to prevent these acts. There are a number of pieces of legislation that have been introduced to address the victims of trafficking.

Do you know who Bessie Coleman, Louise Boyd, and Rachel Carson are? A musical/dramatic monologue presented by Kate Campbell Stevenson, entitled "Forging Frontiers: Women Leaders in STEM," emphasized the challenges met by these three remarkable women.

of AAUW "Pay Equity,
Violence against Women
and Advocacy Issues and
Protocol on the Hill," and
a report on the status of

the National Women's History Museum in D.C.

We nod; we advocate; we should act. Attending the National Legislative Seminar is truly a shot in the arm as well as a call to arms. It is a small step that inspires action. We could take a baby step. We could better effect positive change. Let's choose a target together. Let's choose to act together.


## Theta Chapter

- be accepted and enrolled in a graduate program of a nationally accredited

institution of higher education, preferably pursuing a doctoral degree.

- have not received an International Scholarship previously.
- provide evidence of excellence in scholarship.provide evidence of service to the community.
- Applications may be obtained on the Society's website, www.dkg.org, and must be submitted by February 1 of each vear.

**State Scholarship and Grant** -in-Aid: The Alpha Tau State

Founders' Scholarship

The Alpha Tau State Founder' Scholarship has been established to develop and encourage advanced educational opportunities for Delta Kappa Gamma member. There is at least one scholarship of \$1000 available annually. The number and amount can vary according to the balance in the fund and the established need.

Basic Requirements: The applicant must be an active member in good standing of The Delta Kappa Gamma Society International, Alpha Tau State. First consideration will be given to members of two years or more.

- use the scholarship for graduate level work in an approved institution for higher learning.
- must provide evidence of actual participation and leadership at the chapter and/or state levels of Delta Kappa Gamma.
- meet reasonable standards as far as general health, personality, scholarship, and professional services are concerned.
- Applications may be obtained from the State Scholarship Chairman and must be submitted by April 1 of each year.

## The May B. Leasure Grant-in-Aid

The May B. Leasure Grant-in-Aid was established to offer opportunities for all eligible persons seeking an undergraduate degree in a teacher preparation program. High school seniors and undergraduate college students may apply. Depending on available funds, there is at least one annual grant-in-aid of \$500.

The following are the criteria for determining eligibility:

 a. First consideration will be given to applicants related to Delta Kappa Gamma members.

- b. The grant-in-aid is available for outstanding high school graduates entering teacher preparation programs or for college students completing their teacher preparation.
- c. Applicants must meet reasonable standards relating to general health, personality, professional and/ or community services as well as demonstrate excellence in scholarship.
- d. Sex, race, or religion will not affect the awarding of this grant-in-aid.
  e. Two letters of recommendation are required,

one academic and one

character reference.

f. The applicant will be judged on scholastic achievement, quality and content of essay, and financial need.

Applications may be obtained from the State Scholarship Chairman (see below) and must be submitted by **April 1** of each year.
