In Africa 47 million children do not go to school. The project began with 6 countries and has expanded to 13 today. Money was collected from members, it goes to UNICEF, and they administer the funds. The money may be spent for clean water at school, toilets at school or toiletries, as well as school supplies.



From the Legislative Committee STATE SUPERINTENDENT OF PUBLIC INSTRUCTION

One of the stated goals for the 2015 session is to convert the office of State Superintendent of Public Instruction to an **appointed** position. Indiana is one of 13 states where the Superintendent is elected. In 18 states he/she is appointed by the governor; in 23 by the Board of Education and in 3 by some other method. In a few states there is an elected Director of Education and an appointed Superintendent of Education. Indiana's law seems to be leaning toward allowing the governor to appoint the Superintendent. Currently the governor appoints all of the other State School Board members. Many feel allowing the governor to appoint the Superintendent would avoid the friction which has been present between State Superintendent Ritz and the current School Board.

NUMBERS OF ED MAJORS DECREASE

Ball State reports a 63% decrease in the number of education majors since 2009 and IU reports a 30% decrease over the last decade. The declines are in line with a nationwide decline. Most researchers are putting the blame on corporate reform as well as the low pay paired with the high cost of college. Research says that regardless of the type of institution a student attends, the single most important school-based factor for improving student achievement is the quality of the classroom teacher and school leaders. Research based reforms which work include increasing teacher pay, recruiting the best and brightest in the teaching profession, raising professional standards for teacher preparation, and providing professional development.
