The past year was busy and productive. The state organization's spring convention was held on beautiful Mackinac Island. Approximately two hundred DKG members attended that event at the elegant Grand Hotel and participated in breakout sessions and general membership meetings. In July, Alpha Iota officers and members traveled to Indianapolis for the 2014 International convention. It was a perfect time to meet with representatives from the International level of the organization, other state organization officers and Society members. The 2014-2016 International officers were elected and the Society's Executive Board met to discuss issues, consider the budget and vote on proposals. In August, the President's Advisory Council met to finalize plans for the state organization's fall conference and to discuss other issues, concerns and projects. The Upper Peninsula Fall Conference was held in early October, in Marquette, and offered great breakout sessions, speakers and fellowship. The state organization's fall conference in Battle Creek was well attended and included the fall Executive Board meeting. The conference featured excellent speakers and sessions and an opportunity for people to chat and network with state organization officers, employees, committee chairs and Alpha Iota members. Plans for the 2015 spring state convention began in earnest in October.

Throughout the year, the president made visits to a number of chapter and coordinating council meetings. It was a wonderful opportunity to meet members around the state and learn about the terrific chapter programs and projects that are being presented, enjoyed and implemented by our members.

Approximately 88.5% of the chapter presidents sent in their annual reports. The responses were tallied and the results are summarized here.

1) 56.5% of those reporting initiated new members since January 2014. Five of those members had fewer than five years of teaching experience. Fourteen new members represented greater chapter diversity (age, ethnicity, religion, culture).

2) 61% of those presidents reporting attended a state leadership training event. The most helpful aspects of the training were: receiving, from the state organization president, electronically and in paper form at state events, forms and deadline information well in advance; sharing/talking with other chapter presidents; help with newsletters, yearbooks and websites; regular communication with the state organization president-reminders, suggestions, e versions of forms; and the opportunity to ask questions.

3) 72% of those reporting have a project or projects in support of early-career educators. Most provided supplies, classroom helpers and volunteers, mentoring, mini-grants for projects and conference attendance, scholarships, meals and treats, continuing education credit at DKG meetings, and emotional support.

4) 78% of those reporting have a chapter project or projects that support excellence in education (other than #3 above). Those projects included: helping homeless students; grants and scholarships; mentoring teachers in new positions and grade levels; volunteering in classrooms; science summer camp for girls; working with Literacy Councils, libraries and tutoring; book donations; reading about and discussing new practices in education; Friend of Education awards; projects and presentations at museums; math/science programs for girls; and supplies and grants available to all educators.

5) 37% of those reporting have chosen a way to support the international project, *Schools for Africa*. Most chapters have made monetary donations, while others have sewn dresses for African students or supported other groups building schools and training teachers.

6) Almost all chapters reporting have continued to develop electronic communications and media coverage. Common forms of e-communication include emailed newsletters, meeting information, agendas, and members' news. Some use text messaging to contact members, and a number of chapters maintain a Facebook presence. Chapters have had their projects, scholarship recipients, Friend of Education recipients, programs, and coordinating council events publicized in local newspapers, on television and in community and school newsletters and on websites. Some chapters present their grants and scholarships at school functions and, in the presentation, include a brief description of who and what we are. Many chapters reported making attempts, not always successful, to receive media coverage in their local community. Even when not reported in the news, many feel they have a very visible presence in their area. Volunteering in schools and supporting local charities have given members the chance to introduce others to DKG.

7) There were many ways that chapters communicate and connect with their members. Most use email, newsletters, and chapter yearbooks to share information and reminders. Many use text messaging and Facebook

to contact members. Some chapters mentioned home visits to members who cannot get to meetings. Carpooling has helped some members stay active, involved and connected. For some, sn mail, handwritten notes, and phone calls are used. Most chapters have a phone tree in place for contacting members. Some chapters send notes to members who miss a meeting. Surveys are used to determine members' interests, and cards (birthday, get well, sympathy, thinking of you) are sent. Some meetings are designated as "social" and meetings in the homes of members may bring people closer together. Mentors for new members, informal lunches and activities outside chapter meetings help people stay connected. Involving new members in chapter leadership and projects helps them build a bond with their DKG sisters.

8) Chapters listed many ways in which they are working to sustain their chapter. (see ideas in #7 above). In addition, chapters plan a variety of types of programs, get members involved in meetings and activities, ask for members' input, provide an agenda, recognize accomplishments of individuals, include meals and more social time at meetings, offer time and opportunity for professional collaboration, organize book clubs, and maintain personal contact. Involvement in coordinating council events and attendance at leadership and state events strengthens the chapter. Collaborative volunteerism and work on chapter projects increases time together and value in membership. Inviting guests and recipients of grants, scholarships and Friend of Education awards to meetings and activities, and getting to know chapter members better (highlight members in newsletters and at meetings) can strengthen the chapter. Varying the day of the week and time of meetings, maintaining regular, positive and professional communications, writing a brochure about the chapter, reviewing the purposes and goals of the Society and the chapter, reaching out to former members, planning ice-breakers at meetings, recognizing members' accomplishments and, when possible, keeping meetings short and productive may encourage more member participation. Remember to recruit, retain and regain members! Give them a reason to attend and participate at the meetings.

9) The reports listed ways in which the state and international levels could help chapters and officers. The list included: work to keep dues down; publicize DKG; require less paperwork; provide program and speakers ideas for meetings; share ways to get younger/ new members involved; offer help in finding ways to increase membership; suggest ways to help get members involved in committees and in leadership positions; and lower the cost of attending state and international events. In an effort to cut costs and possibly reduce the dues, share publications and forms on-line. Find and share ways to advertise DKG in the media. Continue to offer Wilma Adams funds, scholarships and SCECH credits at state events. Design easy to navigate websites, help chapters design, set up websites, Facebook pages, and Twitter accounts. Offer student DKG membership for those in Schools of Education. Help chapters coordinate meetings and activities with nearby chapters and offer suggestions for nondues revenue projects. Continue the practice of state officers' visits with chapters. Continue and expand the DKG Art Gallery and create other ways to showcase accomplishments of members.

10) 72% of those responding have a chapter Strategic Action Plan. Twelve chapters did request more information on developing a plan.

11) The top issues chapters are facing include: membership (membership numbers are declining, difficulty in bringing in younger members and re-claiming former members, aging membership, losing members to warmer climes in the winter); leadership (getting members to serve as chapter officers and committee chairs); financial issues (dues are too high for some); struggling in planning programs and procuring speakers; fundraising (need ideas); finding locations for meetings; keeping up with technology; getting more students to apply for grants-in-aid; and getting members involved and interested in state and international events and activities.

12) Chapters are proud of their active involvement in their schools and their community, at cultural events and with charities. They exhibit committed interest in educational and legislative issues. They continue to value the Society and strive to strengthen it at the chapter, state and international levels. Many members are active at the state level. Members value the friendship of DKG sisters and they care for and support each other. They are proud to recognize accomplishments of their DKG sisters. Members are generous with their time and financial support, volunteering in classrooms and providing supplies, grants and scholarships. Chapters and members are proud of that assistance to teachers and students. They are also proud of the wonderful programs and projects they design and support.

Alpha Iota is an amazing, strong group of women who are truly "key women educators." Chapter meetings are professional and diverse, offering wonderful social and networking opportunities. There is a strong feeling of friendship and professional collaboration. The projects and programs that our members support influence so many educators, students and communities. The chapters are upholding the purposes and mission of the Society. All the members of Alpha Iota should be very proud of their involvement and commitment to education, women and students and to DKG.

Alpha Iota's Program of Work Committee sought out and selected speakers and programs for the state's May 1-3, 2015 Pontiac convention. The goal was to offer sessions that address issues that relate to Society business, members' personal growth and enjoyment, and members' professional growth for all attendees, those who are actively working in the educational field as well as those who have retired from full time work. The committee tapped the talent and skills of DKG members and individuals from outside the Society. Suggestions from member's evaluations from previous events and ideas from chapters were taken into consideration when choosing speakers and topics.

The committee appreciates the input and ideas and asks that individuals and chapter officers continue to pass along topics and names of potential speakers. The Program of Work Committee also seeks volunteers to act as presiders at sessions. Volunteers are asked to complete the form available at each state event or contact a member of the Program of Work Committee. Although planning has already begun for the fall workshop to be held in Midland the weekend of September 25-26, 2015, suggestions for that event and future conventions and workshops are welcomed and encouraged.

Members of the Yearbook Committee have perused and evaluated the thirty three yearbooks that were submitted. The yearbooks were all excellent sources of information for members and helped chapters remain cohesive and connected. The publications included entries such as photographs, songs, historical data, information on individuals receiving Friend of Education Awards and grant-in-aid recipients. There is now a place of storage and retrieval of Alpha Iota State materials that must be accessed periodically. The state organization has entered into a contract with KRM: Kent Record Management Inc., *info@kentrecords.com*. Located in Grand Rapids (Headquarters), Muskegon, Kalamazoo, Benton Harbor, and Lansing, with access available from other state locations, specific site contact information and procedures are available from the Historical Document Storage Committee Chairman.

This company provides scanning, disc making, and hard storage in containers manageable for storage and retrieval. They will work with us to have our stored items scanned on demand and delivered electronically. They will deliver objects to a location for pick up and return to the designated storage area following use. The goal of using a central storage provider is to eliminate the need for at-home storage of state materials that are historical in nature and for which access is not often needed. The Historical Document Storage Chairman can ensure and expedite access to stored materials whether they be physically or electronically stored. There is a charge for retrieval or transfer of materials KRM is storing for us. Approval for payment must come from the Alpha Iota State President.

This chairman is one more resource person for state officers and committee chairmen, but the individual holding this position will change periodically. It will be important for the State President, Executive Secretary, Treasurer and other signers to become familiar with this retrieval system as we will rely on them for direction, communication, and approval. The Historical Document Chairman should maintain a journal including what is stored, by whom, and when it was stored. For example: the Alpha Iota State water-proof, fire-proof safe is now at KRM and contains the first nearly 5 decades of hard copy history of the Alpha Iota State Organization. All those documents have been scanned and are available to members electronically on discs held by the Historical Documents Chairman. The purpose of the current system is to lessen the burden on state-involved members who have been storing state materials in their homes. It is exciting that this system is user friendly and readily available to state officers and chairmen who would benefit by putting this storage system to use. As long as a good communication system is in place as to what is stored, by whom and where it is stored, everyone needing particular materials will be able to store and/or access them! I am happy to encourage you to store mindfully for your good and for the good of DKG in Michigan.



During the 2014-2015 year the Communications Committee received 27 newsletters for evaluation. Chapters' newsletters were evaluated using a similar scoring guide as 2014, with the exception that the scoring guide format changed and we offered more points for miscellaneous articles and member information. Because we awarded more points for different types of articles, our scoring is now out of 28 total possible points. Chapters could submit a newsletter that was published from August, 2014 through January, 2015. All submitted newsletters were scanned or copied onto a cd, sent to the committee members and evaluated by the 5 members. Awards and feedback were distributed to the chapters who submitted newsletters for consideration.

Of the 27 newsletters sent in for evaluation, 26 were sent electronically, which demonstrates the success of the "go green" initiative. Some chapters also report using Facebook as a method of communication with their members.

In the Fall of 2014, there was a presentation on using Twitter, Facebook, Edmodo and creating a chapter website (explaining the requirements of International), as well as, other methods of electronic communication and its usefulness in the classroom and for chapter communication.
