The September 12, 2020 Executive Board Meeting minutes were approved as posted and distributed to the membership.

Corrections and additions may still be made at September 25, 2021 Executive Board Meeting. Minutes (DRAFT) were posted on the state website & emailed to all Executive Board members.

- 4. Committee to Approve Minutes for September 25, 2021, Executive Board Zoom Meeting:
  - \*Appointment of three committee members needed

Karen Laskowski (Gamma), Dorothy Todd (Nu), and Linda Scribner (Lambda) were appointed to review the minutes for the September 25, 2021 Meeting.

- 5. **President's Report:** Cheryl Anderson (Delta)
  - \*Zoom License Renewal. International has permanently discontinued the use of Go-To-Meeting in favor of the Zoom Virtual platform and President Cheryl Anderson paid the \$150 Zoom renewal fee for our state. Judy Silker commented that the Zoom and In-Person Options provides for an opportunity to have maximum participation regardless of COVID or not. Cheryl gave an update on her health and said she is recovering well.
- 6. **Membership Report:** Karen Laskowski (Gamma), State 2<sup>nd</sup> Vice President reported that we currently have 180 members with 163 Active, 15 Reserve, 1 Honorary Chapter member, and 1 Honorary State member.
- 7. **Necrology Report:** Karen Laskowski (Gamma), State 2<sup>nd</sup> Vice President reported that we had no members passing since the last Convention. It was later corrected that we had one member pass in May, Virginia "Kitty" Hayes in May.

- 8. **Treasurer's & Finance Report:** Heidi Hull (Omicron), State Treasurer & Linda Getschman (Nu), State Finance Chair
  - \*2021-2022 Proposed Budget (ACTION REQUESTED)

The current budget was presented. The Beginning balance was listed as \$5352 from last year and after dues will have a total of \$7705.00. Expenses for this year are estimated to be \$2927.00.

Other accounts include the Permanent Fund at \$1992, Annie Webb Blanton Scholarship Fund at \$7233 (\$500 Scholarship each year), and the Martha Schulz Doctoral Scholarship at \$30, 068.

Discussion was held about an Actual Financial Report being presented for the Alpha Chi Checking Account being presented so members could see the Actual Deposits and Expenditures for the year. It was stated that State Treasurer Heidi Hull is having difficulty with her eyesight but is planning to present a Financial Report in the future.

Linda Getschman sent a report to International for our State Financial Report.

**MOTION:** Donna Harper made a motion to accept the presented Budget and Pat Goeppinger seconded the motion. With a unanimous consent, the 2021-2022 Alpha Chi Budget was accepted.

- 9. **State Webmaster Report:** Cindy Frazer (Gamma) asked that the members update their current address information as requested so she can make sure our State Data is current.
- 10. **NevadaGram Editor Report:** Gwen Anne Thacker (Delta). Maxine Emm reported that Gwen Anne Thacker has been sent home from the hospital and hospice is currently assisting her. Since Gwen Anne has many duties at our State Level, we need to consider finding members to take over her duties.
  - Pat Goeppinger (Gamma) volunteered to take over as the NVGram Editor, with Cindy Frazer (Gamma) & Donna Harper (Gamma) offering to be on the Committee to assist Pat.
- 11. **Educational Excellence & Nevada Apple Report:** Pat Goeppinger (Gamma), Chair & Cheryl Anderson (Delta), State President. Pat is mailing out notes from the Atlanta Leadership Training in July and is asking Presidents to look over the information. Pat mailed out 2021-2022 Nevada Apple award certificates and holders to all Chapter Presidents.
- 12. Gold Key Report: Cheryl Anderson (Delta), State President
  - \*Updated criteria & application form for 2021-2022. Cheryl noted that there are some additions to the Gold Key Criteria this year.
  - \*Attending the September 25, 2021 Executive Board Zoom meeting is required.
  - \*Chapter bylaw/rules revisions must be submitted to Marlene Killion (Omicron) by March 1, 2022.
  - \*Chapter Yearbook information must be submitted to Candy Rooney, our new State Historian by February 1, 2022. The Yearbook information includes:
    - -A List of 2020-2022 Chapter Officers.

- -A list of Chapter Meetings, Dates, and Special Events.
- -Photos and or News clippings are optional.
- \*Also, a reminder to invite at least one prospective member to a meeting.
- 13. Update on Chapter Rules Revisions due by March 1, 2022: Marlene Killion (Omicron), Co-Chair & Gwen Anne Thacker (Delta), Co-Chair. It was determined that a committee be formed to help Marlene with the Updated Chapter Bylaws for Chapters and planning for revision of the State Standing Rules.
  - Pat Goeppinger (Gamma), Dorothy Todd (Nu), and Heidi Hull (Omicron) will assist Marlene on the Committee. It was determined that copies of the new By-Laws not be printed until the Standing Rules are done.
  - Kudos to Gamma, Nu, and Omicron chapters for submitting their revisions.
- 14. **Rose of Recognition Report:** Pat Goeppinger (Gamma), Chair will include information in the Packet sent to Chapter Presidents.
- 15. **Exemplary Award Report:** Pat Goeppinger (Gamma), Chair will include information in the Packet sent to Chapter Presidents.
- 16. Martha Schultz Doctoral Scholarship Report: Heidi Hull (Omicron), Chair noted that there is over \$30,000 in the Scholarship account. Susan Capistrant (Theta), Cheryl Anderson (Delta), and Heidi Hull (Omicron) State Treasurer are on the Committee. Encourage members to apply.
- 17. **Annie Webb Blanton State Scholarship Report:** Leta Rabenstine (Xi), Chair announced that the Scholarship is being designated for the Southern Chapters this year. Leta suggested that members maybe use the Scholarship in a group effort to receive training so that we can start using the funds. If there are no applications by December 1, the Scholarship will be open to anyone in the State membership.
- 18. **Emergency Fund Report:** Marlene Killion (Omicron), Chair noted that there have been many recent natural disasters and the Emergency Fund is being used by many members in many states. She noted that members receive funds within a week of their request.
  - It was suggested that information be put on our Alpha Chi State Website. It was noted that International prefers that members use the International website; however, the webmaster Cindy said she and Marlene would try to see how they can promote the Emergency Fund on our State Website. Marlene would like Chapters to let her know how much they have contributed to the Emergency Fund so that she can make a State report for the amounts contributed.
- 19. **World Fellowship:** Pat Geoppinger (Gamma), Chair reminded the chapters that World Fellowship should be included in our giving efforts.
- 20. **Leadership Report:** Marlene Killion (Omicron), Co-Chair. Pat Goeppinger offered to be on the Leadership Training Committee and the Executive Board Officers offered to help, as well. This year the Training will be for incoming Chapter Presidents.

Regardless of how the State Convention is done, the State Leadership Training can still take place, but may have to be on a Zoom format.

- 21. **Southwest Regional US Forum Nevada Representative Report:** Pat Goeppinger (Gamma) reported that the two main issues being discussed were Human Trafficking and Mental Health in Schools.
- 22. Arts & Humanities Jury Report, Nevada Representative Report: Ardynne Sprinkle (Theta) reported that Theta Chapter has been working on Art projects. Recently they learned how to use their cell phones to take Nature Pictures. A discussion developed around how Alpha Chi Nevada State or our Chapters can promote the Arts and Humanities. Ardynne suggested that we promote our Chapter's efforts on such activities. It was even suggested that we promote our activities on the State Website or in the NevadaGram. Everyone seemed excited to see Arts and Humanities promoted in our State.

Ardynne would like Chapters to report their projects to her and she will see about promoting our efforts.
