SPOTLIGHT ON MEMBERS

The member spotlight this month is on Eula McKown. Eula joined Zeta Chapter in 1999 while she was teaching at Moody High School. After teaching for 29 years, 24 of those years at Moody H. S., she retired in May, 2002.

Eula was born near Humble, Texas and attended the Aldine I.S.D., graduating from Aldine High School in 1960. After working a year in Houston, she moved to Belton to attend Mary Hardin-Baylor College (now the University of Mary Hardin-Baylor). Eula graduated from MH-BC in 1965 and began teaching 8th grade history in Belton Jr. High. From Belton, she moved to Columbus, Texas and taught high school world history.

After four years of teaching, Eula moved to Irving and began a career as an insurance office adjuster. While working in Dallas, she met her future husband, Jimmy McKown. After marrying him, she moved to McGregor and worked as an insurance adjuster in Waco for one year. The opportunity opened for Eula to return to teaching and she taught homebound for one year through the county school district, teaching in McGregor I.S.D.

Eula then stayed home to begin a family. Her son, Patrick, was born in 1975 and she returned to teaching in 1977, beginning with a half-day position at Moody Jr. High. While teaching in the Moody school district, Eula sponsored Student Council for 20 years, Mock Trial for 19 years, and sponsored the Challenge Team for several years. She also led an Academic Decathlon team one year. In addition, her students entered an anti-drug contest at ESC 12 one year and her students entered the History Fair for many years.

Since retiring, Eula has stayed active in education. After substituting and teaching an ESL class for MCC, she taught 6th grade at Parkview Christian Academy during the 2003-2004 school year. She continues to substitute and stay in touch with school students.

In September, 2006, she was voted to become a member of the Heart of Texas Regional History Fair Board. The purpose of the board is to promote interest in history among elementary and secondary school students. As a nominated member to the HOTRHF Board, Eula was one of the presenters at the HOTRHF's David C. DeBoe Workshop for students, parents and teachers which was held on August 26th at Baylor University's Bill Daniel Student Center.

INTERNATIONAL HEADQUARTERS IS CELEBRATING 50 YEARS

There will be an open house on Thursday, November 16 from 2:30 - 5:30 P.M. to celebrate the 50^{th} year of our International Headquarters Building (1956-2006). Our headquarters building is located at 416 West 12^{th} Street in Austin, Texas.

INTERNATIONAL HEADQUARTERS; FROM THEN TO NOW

For several years, the business of a growing Delta Kappa Gamma was carried out by its founder, Dr. Annie Webb Blanton. Without a building to serve as headquarters, Dr. Blanton stored society materials both in her office on the University of Texas campus and in her room at the Faculty Women's Club at 2610 Whitis Ave.

When Dr. Blanton moved into her newly build home (1909 Cliff Street) around 1936, she used an upstairs screened in porch and bedroom to carry on the correspondence of the Society. The multiplying number of materials were stored in closets and in the attic of her home. During the following bien-nium Delta Kappa Gamma appropriated \$13 a month to rent a room at Dr. Blanton's Cliff Street residence to serve as headquarters office. Soon the space was too small. The Society then rented two rooms that Dr. Blanton has been renting out. The rent was \$30 per month.

When in 1944 Dr. Blanton put her Cliff Street house on the market, the Society rented office space (at \$60 per month) in the Littlefield Building at the corner of Congress Avenue and Sixth Streets. At this time the Society had grown to 22,000 members.

In April, 1946, having outgrown the space at Littlefield Building, the Society leased a five room stucco cottage at 1309 Brazos Street. However, before the time came to renew the lease at Brazos Street, the Society's need for space had once again outgrown its headquarters.

On August 14, 1954, the International Convention and International Executive Board authorized construction of an office building on property owned by the Society on the corner of West Twelfth and San Antonio Streets in Austin (only two and a half blocks from the capitol). "Although the Society had an excellent credit rating at local banks and the valuable lot could have been used as security, never at any time was it necessary to borrow money. Both the architect and contractor were amazed that the Society could pay bills as they were incurred, although there were a few anxious moments during the eighteen months of construction." The furnishings were paid for by member contributions.

The groundbreaking ceremony for the new building was held on July 15, 1955. The cornerstone was laid on November 25, 1955 and the two-story International Headquarters building was dedicated in August of 1956. "A dream had finally been realized." The Society's headquarters is still housed in this building at 416 West Twelfth Street. (Information found on Delta Kappa Gamma web site).

ALPHA STATE MEETING

The Alpha State convention was held at Ford Park in Beaumont on June 15 - 17, 2006. State president, Catherine Davis, presided over the meeting. Her theme for the biennium was "Excellence: A Roadmap to Success." The meeting was packed with numerous CPE workshops, committee training and two general sessions. Zeta members participated in the birthday luncheon and the president's banquet. Linda Ewing participated in the new president's training session and attended the executive board session. It was reported that Alpha State has 13,253 active members, 963 reserve members, 315 chapter honorary members, and 21 state honorary members, 71 active life (stopped in 1964) members, and 23 reserve life for a total membership of 14,646. Gail Herring sang with the state choir. The Beaumont area chapters are to be commended for a successful convention in the mist of the aftermath of Hurricane Katrina. The Zeta members attending the state conference were Gail Herring, Barbara Rountree, Lorraine Dosher, Lou Ayers, Lilian Rathman, Dorothy Stallings, and Linda Ewing.

ZETA MEMBERS GO WEST

Barbara Rountree and Gail Herring spent July 13 - 16 in historic Solvang, California. They were among the key women educators who participated in the Purposeful Living Conference. At the end of the week they traveled by bus to San Diego, California to attend the International convention. Joining them in San Diego were Lilian Rathman and Linda Ewing. The women attended various workshops, the Area VIII breakfast, the Alpha State breakfast, the birthday luncheon, the president's banquet, the necrology ceremony and all of the general sessions. Gail Herring sang with the International Choir and attended a reunion of the Golden Gift recipients. Although busy with convention activities, the ladies took time to visit Coronado Island. Old Town, Seaport Village, and other sites. Lilian and her daughter drove to California. After the convention they took an extended vacation and visited other places in California as well as stopping to visit other sites on the way home. The group will give a report at the October meeting.

ZETA WELL REPRESENTED AT AREA VIII WORKSHOP

Several Zeta members traveled to Temple on September 9 to attend the Area VIII Workshop which was hosted by the Lambda Chapter. Presiding at the meeting was the Area VIII Coordinator, Frieda Grisby. Greetings were brought by the mayor pro tem of Temple, the high school principal of Temple H.S. and Dianne White Delisi. A continental breakfast was provided. The chapter roll call was done by Carolyn Wallace.

The members then attended two breakout sessions and ate a delicious lunch. Gail Herring conducted a session on World Fellowship and Carolyn Wallace presided over the legislative session where Dianne Delisi presented.

Lilian Rathman was recognized for having received the Alpha State Achievement Award and Zeta Chapter received a five-star award for outstanding newsletter on the area level.
